

# Great Minnesota Aviation Gathering Exhibitor Agreement

**THIS AGREEMENT** is made this \_\_\_\_\_ day of \_\_\_\_\_, 2023, by and between the Minnesota Pilots Association,

hereinafter called the Licensor, and \_\_\_\_\_ hereinafter called the Exhibitor.

**WHEREAS**, The Licensor has organized and arranged for the Great Minnesota Aviation Gathering (GMAG) to be held at the

Buffalo Municipal Airport on May 19 and May 20, 2023.

**NOW THEREFORE:** The Licensor, for and in consideration of the payments and agreements on the part of the Exhibitor to be made and performed, hereby grants to the Exhibitor, the right to use space for purpose of displaying an Exhibitor Booth at the GMAG to be held at the Buffalo Municipal Airport on May 19 and May 20, 2023 (the License).

**First:** The License shall be subject to all rules and regulations now and hereafter adopted for the conduct of said GMAG, which are hereby made a part of this agreement and to which the Exhibitor agrees to conform.

**Second:** The Licensor will issue to the Exhibitor two (2) tickets to the GMAG for a one-booth display, four (4) tickets for a two booth display and pro rata to those Exhibitors whose displays occupy bulk space.

**Third:** The Exhibitor will hold the Licensor harmless from any damage, expense or liability arising from any injury or damage to said Exhibitor, his agents, servants, employees, the general public, other exhibitors or to the property of the Exhibitor or other exhibitors, occurring at the Buffalo Municipal Airport, the approaches and entrances thereto, by virtue of his occupancy hereunder or anything connected with said occupancy. The Exhibitor agrees to provide evidence liability insurance, with a minimum limit of \$300,000, listing the Minnesota Pilots Association as an additional and/or named insured prior to occupying said space.

**Fourth:** The Exhibitor agrees to pay \$\_\_\_\_\_400\_\_\_\_\_ dollars for the right to use said space, prior to occupying said space. The Exhibitor will make every attempt to have its booth fully staffed during the hours of the GMAG.

**Fifth:** The Exhibitor recognizes and acknowledges the Licensor has incurred expenses and has obligated itself for expenses in organizing and arranging for the GMAG, including expenses for rent and advertisement and that Licensor will continue to incur additional expenses in the production of the GMAG and that these services are of benefit to the Exhibitor. It is hereby agreed that should the Exhibitor fail to make payment by noon, Wednesday, April 26, or should the Exhibitor otherwise terminate this Agreement or not appear on or before 8:00 a.m. on the Licensor's designated opening day and participate in said GMAG, all rights of the Exhibitor hereunder shall cease and terminate, and any payments made shall be retained by the Licensor as liquidated damages for breach of this Agreement and that the Licensor may thereupon resell or otherwise reuse said space.

**Sixth:** The License may be terminated by the Licensor at any time on the breach of any other of the conditions hereof by the Exhibitor, and thereupon all his rights hereunder shall cease and terminate, and any payments made by him on account hereof prior to termination shall be retained by the Licensor as liquidated damages of such breach, and Licensor may thereupon resell or otherwise reuse said space.

**Seventh:** The Exhibitor hereby names \_\_\_\_\_ as his duly authorized representative in charge of this exhibit.

**Eighth:** The Exhibitor shall not assign this License, or sublet, or license the whole or any part of the space hereby contracted for.

**Ninth:** This contract is valid only for the 2023 GMAG event and provides no guarantees for exhibit space in future years for any shows produced by Licensor.

**Tenth:** This agreement shall be binding upon the parties hereto and their respective executor, administrators, successors and assigns.
